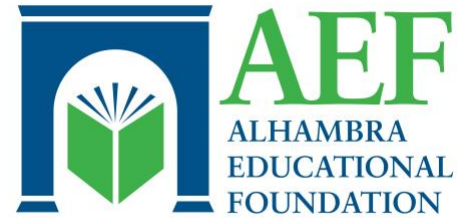


GREAT SCHOOLS START WITH YOU!
