We are seeking substitute teachers for grades K-8 for enrichment and 'getting ready' classes for all grades. - This year's elementary school Summer Academy will be June 3 through July 12. (5 days a week)
- Summer Academy hours at Marguerita School are: K-3 classes: 8:30am 1:00pm; and grades 4-8: 8:30am – 10:30am, 10:45am – 1:00pm.
- Afternoon Day Camp class for grades K-3 at Marguerita School from 1:00-3:30pm and 1:00-5:30
- Afternoon grades 4-8 classes are at San Gabriel High School from 1:30pm-3:30pm and 3:30pm-5:30pm.
- Pay for all substitute teachers is \$45 per hour (2 hours teaching and .5 of 'prep time) or full day (4 hours teaching and .5 'prep time.').
- All employees will be employees of AEF and receive Social Security credits; no PERS or STRS.
- Substitute Teachers will be on-call temporary employees of AEF and will not earn sick time.
- Substitute Teachers will report to the AEF Summer Academy Principal.
